SINCE OUR REGIONAL PLANNER JOINED STAFF IN MAY 2017, 54 OF THE 75 GOVERNMENTS IN GREATER PHILADELPHIA HAVE PASSED RESOLUTIONS IN FAVOR OF BUILDING 500 MILES OF CIRCUIT TRAILS BY 2025. WE HAVE GONE FROM TWO ACTIVE VOLUNTEER LED COUNTY AFFILIATE GROUPS TO SIX. AT THE STATE LEVEL, THE BICYCLE OCCUPANCY PERMIT-WHICH HALTED ALL BICYCLE LANE CONSTRUCTION IN THE PHILADELPHIA SUBURBS FOR OVER A DECADE-HAS BEEN LIFTED. SINCE THIS MODIFICATION, MANY LOCAL GOVERNMENTS ARE SHOWING INTEREST FOR INSTALLING BICYCLE LANES IN THEIR COMMUNITIES. ON THE CITY LEVEL, WE HELD OUR FIRST LISTENING SESSION FOR THE VISION ZERO ALLIANCE IN WEST PHILADELPHIA AFTER 11 BLOCKS, OR 1 MILE, OF PHILADELPHIA'S FIRST PROTECTED BIKE LANES WERE INSTALLED ON WEST
